11. Drill Down clarifications
- a. A-ten-hut: head movement is optional/team style
 - b. As you were: During by-the-numbers, if the caller calls any command other than a-ten-hut after parade rest, participants should not say as you were until after the caller says "1"
 - c. Participants are required to say "As you were" when appropriate; caller has the option of repeating back (Have to say As you were....no ma'mm or sir)
 - d. Parade rest: hand and head position determined by team style
